CORRIGENDUM

**Read: Notification No. DTE/ DJ-GIFT/EDUCATION SCHEME/2021/448,
dated 07/06/2021.**


In the above notification, provisions under Clause 4.1 may be read as:

- a student should be admitted under General, SC, ST, OBC, GN, PwD, EWS, FF categories and Management Quota seats, as per the Prospectus for admissions, issued by Directorate of Technical Education, Govt. of Goa.
- a student admitted under ESM, CSP, NRI, LA, OGA, GULF Categories shall be eligible to avail the Scheme, if either of the parents/grandparents of the applicant is born in Goa.
- a student admitted under ESM Category shall also be eligible to avail the Scheme, if applicant has 10 years residence in Goa, preceding his application for admission.
- a student admitted under Gulf Category shall also be eligible to avail the Scheme, provided he/she fulfils the General Category criteria as stated in the Prospectus.
- a student admitted to Direct Second Year (Lateral Entry) shall be eligible to avail the Scheme, provided :
 1. He/She has passed qualifying Diploma exam from BTE, Goa. **OR**
 2. Either of the parents/grandparents of the applicant is born in Goa. **OR**
 3. Student has passed Std. X/XII exam in the State of Goa and has 10 years residence in Goa, preceding his/her Diploma admission outside the State.
